### RESOLUTION NO. 2023-11-567

**RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT- SMALL VALUE PROCUREMENT AS AN ALTERNATIVE MODE OF PROCUREMENT IN THE PURCHASE OF VETERINARY AND OTHER SUPPLIES AND MATERIALS FOR THE USE OF THE MUNICIPAL AGRICULTURE OFFICE IN CONDUCTING ASF (AFRICAN SWINE FEVER) SURVEILLANCE AND MANAGING ACTIVITIES FOR THE PREVENTION OF ASF AND OTHER ANIMAL DISEASES PREVALENCE IN THE MUNICIPALITY OF SOCORRO.**

**WHEREAS**, per Purchase Request No. 2023-11-546 dated November 29, 2023, the Municipality of Socorro has to purchase of veterinary and other supplies and materials for the use of the Municipal Agriculture Office in conducting ASF (African Swine Fever) surveillance and managing activities for the prevention of ASF and other animal diseases prevalence in the Municipality of Socorro with an Approved Budget for the Contract of Seventy Eight Thousand Nine Hundred Twenty Pesos (Php. 78,920.00) ;

**WHEREAS**, under Republic Act No. 9184 (RA 9184), otherwise known as “Government Procurement Reform Act” (GPRA), and its Revised Implementing Rules and Regulations (RIRR), all procurement shall be undertaken through competitive public bidding except only under highly exceptional cases where the procuring entity may resort to alternative methods of procurement; and the same shall be subject to the prior approval of the Head of the Procuring Entity.

**WHEREAS**, the abovementioned procurement is recommended for Negotiated Procurement under Small Value Procurement considering that such procurement does not exceed the threshold of Two Hundred Thousand (P200,000.00) as prescribed in Annex H of 2016 Revised Implementing Rules and Regulations of RA 9184;


**WHEREAS**, under Section 53.9 of RA 9184, Small Value Procurement is one of cases that calls for the use of Negotiated Procurement;

**NOW THEREFORE**, we the members of the Bids and Awards Committee do hereby **RESOLVED** as it is **HEREBY RESOLVED**

- 1) To recommend that the purchase of veterinary and other supplies and materials for the use of Municipal Agriculture Office in conducting ASF (African Swine Fever) surveillance and managing activities for the prevention of ASF and other animal diseases prevalence in the Municipality of Socorro with an Approved Budget for the Contract of Seventy Eight Thousand Nine Hundred Twenty Pesos (Php. 78,920.00) be procured through alternative mode of procurement – Negotiated Procurement under Small Value Procurement;
- 2) To recommend for approval of the Municipal Mayor the foregoing findings.




