**CONTRACT AGREEMENT**

THIS AGREEMENT, made this 12 day of July 2024 between Municipality of Socorro at E.D. Villanueva Street, Zone IV, Socorro, Oriental Mindoro (hereinafter called the "Entity") and Winkonstract Enterprises at Sto. Niño, Calapan City, Oriental Mindoro (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the contractor execute of Establishment/Construction of Potable Water System at Barangay Bagsok with contract identification number C2024-012 (hereinafter called "the Works") and the Entity has accepted the Bid for Two Million Nine Hundred Ninety Four Thousand Seven Hundred Thirty Nine Pesos and Seven Centavos (Php. 2,994,739.07) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:

- a. Philippine Bidding Documents (PBDs);
  - i. Drawings/Plans;
  - ii. Specifications;
  - iii. Bill of Quantities;
  - iv. General and Special Conditions of Contract;
  - v. Supplemental or Bid Bulletins, if any;
- b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. Performance Security;
- d. Notice of Award of Contract and the Bidder's conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such

as the Duly Signed Construction Schedule and S-Curve, Duly Signed Manpower Schedule, Duly Signed Equipment Utilization Schedule, Duly Signed Construction Safety & Health Program Approved by the DOLE, Certificate of Site Inspection, Duly Signed Construction Method in Narrative Form, Duly Signed PERT-CPM, Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of Two Million Nine Hundred Ninety-Four Thousand Seven Hundred Thirty-Nine Pesos and Seven Centavos (Php. 2,994,739.07) or such other sums as may be ascertained, Winkonstruct Enterprises agrees to Establishment/Construction of Potable Water System at Barangay Bagsok in accordance with his/her/its Bid.
4. The Municipality of Socorro agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
