CONTRACT AGREEMENT

THIS AGREEMENT, made this 27th day of December 2024 between Municipality of Socorro at E.D. Villanueva Street, Zone IV,Socorro, Oriental Mindoro (hereinafter called "the Entity") of the one part and Marvin's Surveying Office & General Services at Sta.Rita, Pinamalayan, Oriental Mindoro (hereinafter called "the Consultant").

In consideration of the payments to be made by the Entity to the Consultant as hereinafter mentioned, the Consultant hereby covenants with the Entity to execute and complete the Consulting Services and remedy any defects therein in conformity with the provisions of this Consultant in all respects.



4. The Entity hereby covenants to pay the Consult in consideration of the execution and completion of the Consulting Services, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
