CONTRACT AGREEMENT

THIS AGREEMENT, made this 27th day of December 2024 between Municipality of Socorro at E.D. Villanueva Street, Zone IV, Socorro, Oriental Mindoro (hereinafter called "the Entity") of the one part and Marvin's Surveying Office & General Services at Sta. Rita, Pinamalayan, Oriental Mindoro (hereinafter called "the Consultant").

WHEREAS, the Entity is desirous that the Consultant execute Preparation of Site Development Plan and Subdividing of Lots for Mausoleum at Socorro Public Memorial Garden with contract identification number C2024-032 (hereinafter called "the Works") and the Entity has accepted the Bid for Seven Hundred Ninety Nine Thousand Nine Hundred Seventy Five Pesos (Php. 799,975.00) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - (f) Addenda and/or Supplemental/Bid Bulletins, if any;
 - (g) Bid forms, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes;
 - (h) Eligibility requirements, documents and/or statements;
 - (i) Performance Security;
 - (j) Credit line issued by a licensed bank, if any;
 - (k) Notice of Award of Contract and the Bidder's conforme thereto;
 - (l) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Entity to the Consultant as hereinafter mentioned, the Consultant hereby covenants with the Entity to execute and complete the Consulting Services and remedy any defects therein in conformity with the provisions of this Consultant in all respects.



4. The Entity hereby covenants to pay the Consult in consideration of the execution and completion of the Consulting Services, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
