RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT - SMALL VALUE PROCUREMENT AS AN ALTERNATIVE MODE OF PROCUREMENT IN THE PURCHASE OF SPARE PARTS FOR THE REPAIR AND MAINTENANCE OF MUNICIPAL VEHICLES

WHEREAS, per Purchase Request No.2023-11-550 dated November 29,2023, the Municipality of Socorro has to purchase of spare parts for the repair and maintenance of municipal vehicles for the Approved Budget for the Contract of One Hundred Ninety Nine Thousand Six Hundred Pesos (Php. 199,600.00);

WHEREAS, under Republic Act No. 9184 (RA 9184), otherwise known as Government Procurement Reform Act" (GPRA), and its Revised Implementing Rules and Regulations (RIRR), all procurement shall be undertaken through competitive public bidding except only under highly exceptional cases where the procuring entity may resort to alternative methods of procurement; and the same shall be subject to the prior approval of the Head of the Procuring Entity;

WHEREAS, the above mentioned procurement is recommended for Negotiated Procurement under Small Value Procurement considering that such procurement does not exceed the threshold of Two Hundred Thousand Pesos (Php. 200,000.00) as prescribed in Annex H of 2016 Revised Implementing Rules and Regulations of RA 9184; PRESIDENCE
