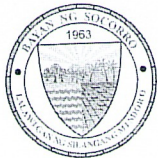

### RESOLUTION NO. 2023-12-603

#### RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT- SMALL VALUE PROCUREMENT AS AN ALTERNATIVE MODE OF PROCUREMENT IN THE PURCHASE OF MEALS AND SNACKS FOR THE ATTENDEES OF DIFFERENT ACTIVITIES CONDUCTED BY THE LGU

WHEREAS, per Purchase Request No. 2023-12-582 dated December 04, 2023 the Municipality of Socorro has to purchase Meals and Snacks for the attendees of different activities conducted by the LGU with an Approved Budget for the Contract of One Hundred Eighty Nine Thousand Seven Hundred Fifty Pesos (Php. 189, 750.00);

WHEREAS, under Republic Act No. 9184 (RA 9184), otherwise known as "Government Procurement Reform Act" (GPRA), and its Revised Implementing Rules and Regulations (RIRR), all procurement shall be undertaken through competitive public bidding except only under highly exceptional cases where the procuring entity may resort to alternative methods of procurement; and the same shall be subject to the prior approval of the Head of the Procuring Entity.

WHEREAS, the above mentioned procurement is recommended for Negotiated Procurement under Small Value Procurement considering that such procurement does not exceed the threshold of Two Hundred Thousand (P200,000.00) as prescribed in Annex H of 2016 Revised Implementing Rules and Regulations of RA 9184;

WHEREAS, under Section 53.9 of RA 9184, Small Value Procurement is one of cases that calls for the use of Negotiated Procurement;

NOW THEREFORE, we the members of the Bids and Awards Committee do hereby RESOLVED as it is HEREBY RESOLVED

- 1) To recommend that the purchase of Meals and Snacks for the attendees of different activities conducted by the LGU with an Approved Budget for the Contract of One Hundred Eighty Nine Thousand Seven Hundred Fifty Pesos (Php. 189, 750.00 ); be procured through alternative mode of procurement – Negotiated Procurement under Small Value Procurement;
- 2) To recommend for approval of the Municipal Mayor the foregoing findings.
