RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT- SMALL VALUE PROCUREMENT AS AN ALTERNATIVE MODE OF PROCUREMENT IN THE SUPPLY AND DELIVERY OF AIRCONDITIONING UNIT FOR THE USE OF OFFICE OF THE MUNICIPAL MAYOR AND MUNICIPAL ASSESSOR'S OFFICE

WHEREAS, per Purchase Request No. 2025-02-021 dated February 7, 2025, the Municipality of Socorro has to purchase air conditioning unit for the use of Office of the Municipal Mayor and Municipal Assessor's Office with an Approved Budget for the Contract of One Hundred Six Thousand Five Hundred Pesos (Php. 106,500.00);

WHEREAS, under Republic Act No. 9184 (RA 9184), otherwise known as "Government Procurement Reform Act" (GPRA), and its Revised Implementing Rules and Regulations (RIRR), all procurement shall be undertaken through competitive public bidding except only under highly exceptional cases where the procuring entity may resort to alternative methods of procurement; and the same shall be subject to the prior approval of the Head of the Procuring Entity.

WHEREAS, the abovementioned procurement is recommended for Negotiated Procurement under Small Value Procurement considering that such procurement does not exceed the threshold of Two Hundred Thousand (P200,000.00) as prescribed in Annex H of 2016 Revised Implementing Rules and Regulations of RA 9184;

WHEREAS, under Section 53.9 of RA 9184, Small Value Procurement is one of cases that calls for the use of Negotiated Procurement;

NOW THEREFORE, we the members of the Bids and Awards Committee do hereby **RESOLVED** as it is **HEREBY RESOLVED**

- 1) To recommend that the Supply and Delivery of Airconditioning Unit for the use of Office of the Municipal Mayor and Municipal Assessor's Office with an Approved Budget for the Contract of One Hundred Six Thousand Five Hundred Pesos (Php. 106,500.00) be procured through alternative mode of procurement – Negotiated Procurement under Small Value Procurement;
- 2) To recommend for approval of the Municipal Mayor the foregoing findings.
