RESOLUTION NO. 2025-02-019

RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT- SMALL VALUE PROCUREMENT AS AN ALTERNATIVE MODE OF PROCUREMENT IN THE PURCHASE OF JANITORIAL SUPPLIES FOR THE USE IN THE MAINTENANCE OF CLEANLINESS AND ORDERLINESS OF PUBLIC MARKET, MUNICIPAL BUILDING AND OTHER PUBLIC UTILITIES

WHEREAS, per Purchase Request No. 2025-02-014 dated February 05, 2025, the Municipality of Socorro has to purchase janitorial supplies for the use in the maintenance of cleanliness and orderliness of Public market, Municipal building and other public utilities with an Approved Budget for the Contract of One Hundred Sixty Thousand Seven Hundred Thirty Eight Pesos (Php.160,738.00);

WHEREAS, as a general rule, all procurement shall be done thru competitive public bidding except whenever justified by the conditions in order to promote economy and efficiency, may resort to any of the alternative mode of procurement;

WHEREAS, the above-mentioned procurement is recommended for Negotiated Procurement under Small Value Procurement considering that such procurement does not exceed the threshold of Two Hundred Thousand (P200,000.00) as prescribed in Annex H of 2016 Revised Implementing Rules and Regulations of RA 9184;


WHEREAS, under Section 53.9 of RA 9184, Small Value Procurement is one of cases that calls for the use of Negotiated Procurement;

NOW THEREFORE, we the members of the Bids and Awards Committee do hereby RESOLVED as it is hereby HEREBY RESOLVED -


- 1) To recommend that the purchase of janitorial supplies for the use in the maintenance of cleanliness and orderliness of Public market, Municipal building and other public utilities with an Approved Budget for the Contract of One Hundred Sixty Thousand Seven Hundred Thirty Eight Pesos (Php.160,738.00); be procured through alternative mode of procurement – Negotiated Procurement under Small Value Procurement;
- 2) To recommend for approval of the Municipal Mayor the foregoing findings.


