WHEREAS, the Municipality of Socorro through its Bids and Awards Committee, advertised and posted the Invitation to Bid for the Installation of Solar Streetlights in the PhilGEPS website, LGU website and at the conspicuous places in the premise of the Municipality of Socorro on February 26, 2025- March 17, 2025 under IB No. 2025-02-008;

WHEREAS, in response to said advertisement, JSLBuilders and Construction Supply and RJJJ Engineering Services who both purchased bidding documents on March 4, 2025 and March 17, 2025, respectively and JSLBuilders and Construction Supply submitted its bid on March 17, 2025 while RJJJ Engineering Services failure to submit its bid;

WHEREAS, during the preliminary evaluation of bids, the technical and financial proposal of JSLBuilders and Construction Supply were both found to be substantially complying;

WHEREAS, upon post-qualification or careful examination, validation and verification of all eligibility, technical and financial requirements submitted by the bidder with the Single Calculated Bid, the bid of JSLBuilders and Construction Supply was found to be responsive;
