RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT- SMALL VALUE PROCUREMENT AS AN ALTERNATIVE MODE OF PROCUREMENT IN THE PURCHASE OF FESTIVAL COSTUMES TO BE USED BY THE CONTINGENTS FROM LEUTEBORO NATIONAL HIGH SCHOOL IN LINE WITH THEIR PARTICIPATION TO THE PAKAPYA AGTIKE FESTIVAL STREET DANCING AND IN PLACE DANCING COMPETITION TO BE HELD ON JUNE 22, 2025 IN COMMEMORATION OF 62ND FOUNDING ANNIVERSARY OF THE MUNICIPALITY OF SOCORRO

WHEREAS, per Purchase Request No. 2025-05-130 dated May 27, 2025, the Municipality of Socorro has to purchase festival costumes to be used by the contingents from Leuteboro National High School in line with their participation to the Pakapya Agtike Festival street dancing and in place dancing competition to be held on June 22, 2025 in commemoration of 62nd Founding Anniversary of the Municipality of Socorro with an Approved Budget for the Contract of Seventy Five Thousand Pesos (Php.75,000.00);

WHEREAS, as a general rule, all procurement shall be done thru competitive public bidding except whenever justified by the conditions in order to promote economy and efficiency ,may resort to any of the alternative mode of procurement;

WHEREAS, the above-mentioned procurement is recommended for Negotiated Procurement under Small Value Procurement considering that such procurement does not exceed the threshold of Two Hundred Thousand (P200,000.00) as prescribed in Annex H of 2016 Revised Implementing Rules and Regulations of RA 9184;

WHEREAS, under Section 53.9 of RA 9184, Small Value Procurement is one of cases that calls for the use of Negotiated Procurement;
