RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT- SMALL VALUE PROCUREMENT AS AN ALTERNATIVE MODE OF PROCUREMENT IN THE PURCHASE OF FOOD STUFF TO BE USED IN THE PREPARATION OF MEALS AND SNACKS FOR THE DANCING CONTINGENTS AND GUESTS DURING THE HOLDING OF PAKAPYA AGTIKE FESTIVAL IN LINE WITH THE CELEBRATION OF THE $62^{
m ND}$ FOUNDING ANNIVERSARY OF THE MUNICIPALITY OF **SOCORRO**

WHEREAS, per Purchase Request No. 2025-06-163 dated June 9, 2025, the Municipality of Socorro has to purchase food stuff to be used in the preparation of meals and snacks for the dancing contingents and guests during the holding of Pakapya Agtike Festival in line with the celebration of the 62nd Founding Anniversary of the Municipality of Socorro with an Approved Budget for the Contract of Fifty Eight Thousand Six Hundred Sixty Eight Pesos (Php.58,668.00);

WHEREAS, as a general rule, all procurement shall be done thru competitive public bidding except whenever justified by the conditions in order to promote economy and efficiency, may resort to any of the alternative mode of procurement;

WHEREAS, the above-mentioned procurement is recommended for Negotiated Procurement under Small Value Procurement considering that such procurement does not exceed the threshold of Two Hundred Thousand (P200,000.00) as prescribed in Annex H of 2016 Revised Implementing Rules and Regulations of RA 9184;

WHEREAS, under Section 53.9 of RA 9184, Small Value Procurement is one of cases that calls for the use of Negotiated Procurement;

NOW THEREFORE, we the members of the Bids and Awards Committee do hereby RESOLVED as it is hereby HEREBY RESOLVED -

- 1) To recommend that the purchase of food stuff to be used in the preparation of meals and snacks for the dancing contingents and guests during the holding of Pakapya Agtike Festival in line with the celebration of the 62nd Founding Anniversary of the Municipality of Socorro with an Approved Budget for the Contract of Fifty Eight Thousand Six Hundred Sixty Eight Pesos (Php.58,668.00) be procured through alternative mode of procurement - Negotiated Procurement under Small Value Procurement;
